Sunday May 22nd. We will have breakfast at the lodge and then everyone is free to go home any route back you choose, or stay longer in the area.


A complete itinerary will be provided at the start of our trip including maps with stop locations on the way up there as well as Park entrance fees and info.



# Southern Colorado Weekend Highway of Legends Drive

I am planning a weekend trip to La Veta, Colorado in order to drive the Highway of Legends, Colorado Hwy 12, between La Veta and Trinidad going around the west and south side of Spanish Peaks. It is a winding, scenic road in the mountains of Southern Colorado. La Veta is a small artsy town west of Walsenburg. There is a block of rooms with king beds on hold for us at the Rio Cucharas Inn on Hwy 160 west of Walsenburg and before the turnoff for La Veta and Hwy 12. It is on the north side of Hwy 160. If you prefer 2 queen beds, just tell them when you make the reservation. The price is: \$74.90 for 1 person and \$85.60 for 2. I don't remember if that includes tax. The manager is Rollie and the phone number for **Rio Cucharas** Inn is: 719 738 1282. Tell them you are with the Z Car Club of Colorado as there is a block of rooms with king beds on hold for us. He will hold them until June 23. If you make a reservation and need to cancel, make sure you do it at least 24 hours in advance.




